Textual Information(1)	<p>Pursuant to the Resolution Plan approved by the Honble NCLT, Mumbai Bench vide order dated 15th October, 2024, the equity share capital of the Company has been proposed to be restructured involving reduction/extinguishment of existing promoter shareholding and issue/allotment of new equity shares to the Resolution Applicant, nominees and Public. The application for approval and related corporate actions are under process with the Stock Exchange(s) and Depositories. Accordingly, the shareholding pattern reported herein represents the position as per depository records as on 30.09.2025. As mentioned earlier, an application has already been submitted to the stock exchange for the reduction/extinguishment of the share capital held by the former promoter of the Company, and the process is currently underway. However, the said promoter is no longer associated with the Company. Until the Company receives the requisite approval and completes the necessary corporate actions, the name of the promoter will continue to appear in the records of the depositories. Accordingly, the Company has disclosed this information under the 'promoter' category.</p>
